Pursuant to Article 7, paragraph 2 of the Law on the Central Register of Temporary Restrictions of Rights of Entities Registered with the Serbian Business Registers Agency (RS Official Gazette, No, 112/15) and Article 17, paragraph 4 and Article 24 of the Law on the Government (RS Official Gazette, No, 55/05, 71/05 – correction, 101/07, 65/08, 16/11 – Constitutional Court (CC), 72/12, 7/14 – CC and 33/14), at the proposal of the Serbian Business Registers Agency,

the Minister of Economy hereby enacts this

#### RULEBOOK

on the Classification of the Grounds for Temporary Restrictions of Rights

#### Article 1

This Rulebook shall stipulate the Classification of the grounds for the temporary restriction of rights of entities registered with the Serbian Business Registers Agency (hereinafter: Classification), which is printed along with this Rulebook and is an integral part thereof.

## Article 2

The Classification shall systematize the grounds for temporary restrictions of rights of entities registered with the Serbian Business Registers Agency.

The Classification shall determine the codes of all grounds for temporary restrictions of rights for the purposes of registration with the Central Register.

## Article 3

This Rulebook shall enter into force on the eighth day from the date of publication in the Official Gazette of the Republic of Serbia.
